Exact location assignments will not be given out until the day of the event at the check in station.

### **Payment:**

You are not considered a vendor until a payment is received. Approved vendors will receive an "application approved" email.

### **Cancellation Policy:**

NO refunds or rain checks for vendor cancellations or for inclement weather.

### **Merchandise:**

Merchandise will be limited by type and location. We are especially interested in artisan items, local craftwork and unique finds. We reserve the right to limit or refuse certain types of commercially made imported items. You will need to display a copy of your State Sales Tax Permit at your booth.

### **Booth set up:**

All booths should plan on using heavy weights, as booths will be set up on pavement and no staking will be allowed. Vendors are required to provide their own tents/canopies, tables and displays. All booth spaces are 12'x12'.

A copy of your Sales Tax permit must be uploaded when you fill out the application. You are also required to display your sales tax permit in your booth during the event.

### **Electricity/Lighting:**

Power will be supplied to vendors in Elf Acres ONLY. No generators will be allowed except approved by the vendor coordinator. Approved generators must be of the “quiet type” with low decibel ratings. All vendors will be limited to ONE outlet for electricity. Coleman style lanterns and battery operated lights may also be used for lighting. Electricity is to be used for lighting only. No heaters, fans, etc.

### **Vendor Parking:**

Vendors’ vehicles MUST be out of the shopping area no later than 5:00 PM on Friday and no later than 9:00 am on Saturday. Vendors will be directed to vendor parking at the time of check in.

### **Application / Payment Process:**

Complete the appropriate online Vendor Application below. We accept check or credit card. You can pay online with a cc. If you plan to pay with a check, please indicate that on your applications.

### **Non-Profit Organizations/Chamber Members:**

Non-Profit Organizations and Members of the Hondo Area Chamber of Commerce receive a \$25 discount off of booth fees. ***USE CODE ‘CIGC’ at checkout to receive the discount.***

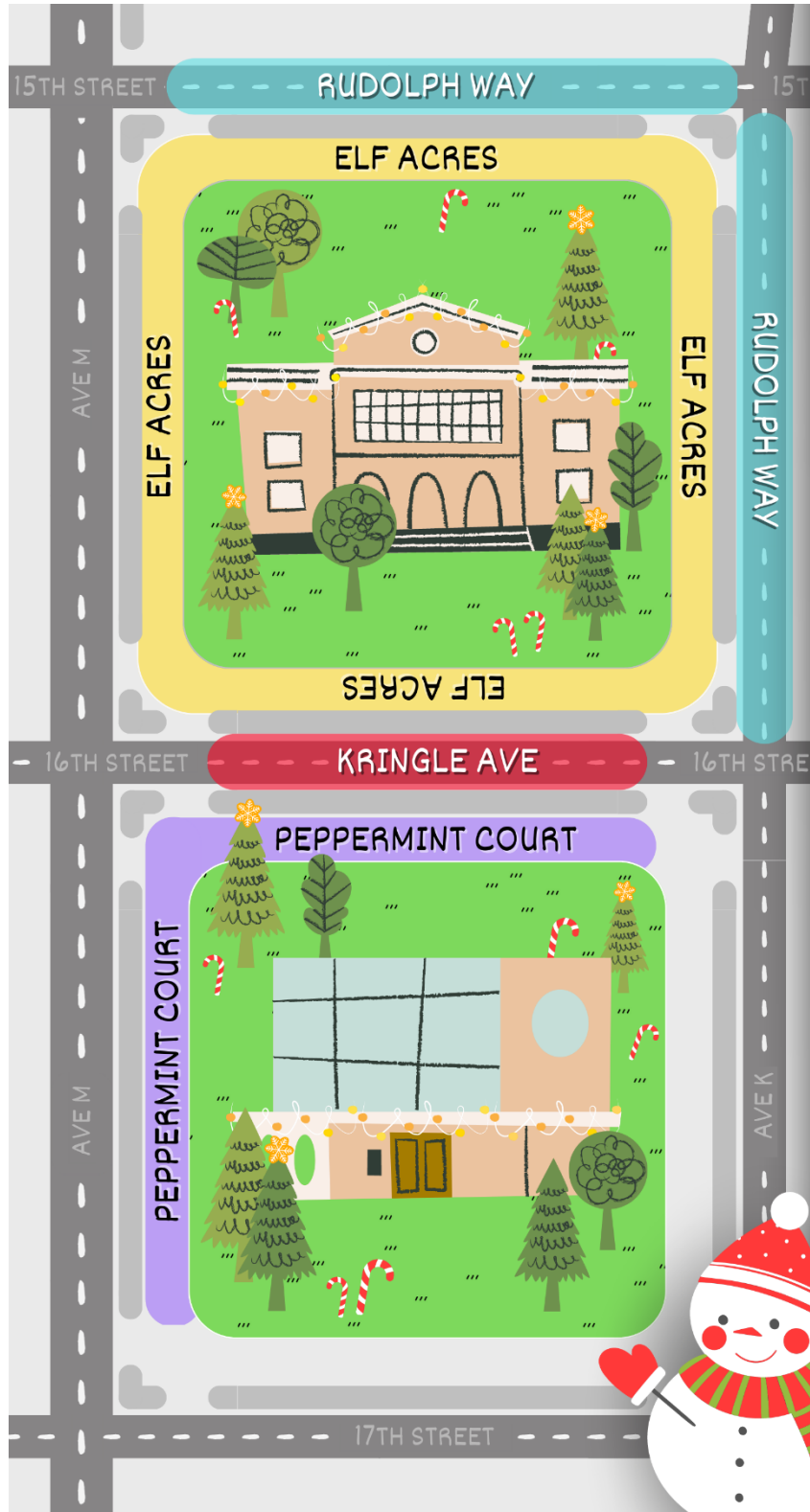
### Food Vendors

Food vendors will be limited by type and number of items sold. Vendors are to submit their menu along with their application for approval. Food vendors are required to have the appropriate health permits from the Medina County Environmental Health Department. 830.741.6195. All other state and local inspections must be displayed as well as your State Sales Tax Permit.

### Non-Profit Organizations/Chamber Members:

Food vendors that are considered Non-Profit Organizations or Members of the Hondo Area Chamber of Commerce receive a \$50 discount off of booth fees. **USE CODE 'FOOD' at checkout to receive the discount.**
